Subject: Clarification - 2018 White House Easter Egg Roll Tickets

To clarify, an appointee (PAS, PA, NC-SES, SKC) is only eligible to obtain a ticket if they have a child that is 13 years or younger. Also, a second adult is able to attend with the political appointee and child. For example, if there is an appointee who is married with an 8 year old, all 3 would receive a ticket and be able to attend.
