Dear Mr. Maskin:

I am lead counsel for plaintiff Nevada Power Company in this litigation. You are lead counsel for defendant Westinghouse Electric Corporation in this litigation. This morning I called you with a simple request to change a deposition schedule that had been disrupted by your client's disobedience of a Court order. You refused to deal with me directly and insisted that I deal with your junior counsel. You argued with me for over 45 minutes about whether you would deal with me. The record is clear on the transcript of the deposition that this occurred. This has been a pattern of conduct on your part since the current round of depositions began.

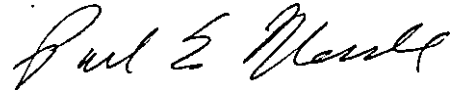
Following the point where you refused to talk with me any further, I was forced into a process that took more than an hour and a half with your junior counsel. The entire matter should have been resolved in three to five minutes, and the only matter left pending when you refused to deal with me further was agreeing on specific language to reflect your agreement with me.
