Mary,

Here is the most recent EU document and we understand that this is what has been approved and will be published in March. Their is a 3-year transition period so the regulation does not enter into force until March 2020.

The limits are 25 ppb PFOA and 1,000 ppb for a combination of PFOA-related substances. There is no end date for the use of existing stocks of telomer-based foams.

I also attached are article that discusses its approval by the REACH committee.

>will see at the beginning of the document is the original proposal by
>Germany and Norway, then the opinions of the Risk Assessment Committee
>and the Committee for Socio-economic analysis (SEAC). SEAC has
>proposed the
>1000 ppb level per substance for foam. The European Commission will
>usually give deference to the SEAC's opinion.
>
>Based on this input, the European Commission will develop an amendment
>to the list of restrictions (Annex XVII of REACH) for approval by the
>EU Parliament and Commission. Then it will be a regulation.
