1952 ANNUAL MEETING

The secretary reported that in accordance with the instructions of the Board, issued at the time of the annual meeting in 1951, he had made arrangements with the Drake Hotel, Chicago, for the 1953 annual meeting on April 24-25, 1953, being the Friday and Saturday preceding the meeting of the American Zinc Institute in St. Louis on the following Monday and Tuesday.

The point was raised that the 1953 meeting would be the silver anniversary of the Lead Industries Association and a suggestion was made that something special should be done to commemorate this event. The Board felt that it would be nice if the meeting could be held at some good resort hotel, such as the Greenbrier, at White Sulphur Springs, W. Va. The secretary pointed out that it might be difficult to obtain accommodations at such hotels on only a year's notice as most of them are booked up for two or more years in advance. He was instructed, however, to see what arrangements could be made at The Greenbrier or some similar hotel for both 1953 and 1954, the dates, if possible, to be close to the dates of the American Zinc Institute meeting.

CONTRIBUTION TO A.S.T.M. GOLDEN JUBILEE

The secretary read a letter he had received from Mr. G. H. Clamer, chairman of a subcommittee of the A.S.T.M. to solicit funds for the A.S.T.M. 50th anniversary meeting, a copy of which is attached as Exhibit "B."

Recognizing that the Association had never been approached in this manner for a similar contribution, nevertheless the Board felt that a contribution of \$100, as requested, should be made towards the expense of the 50th anniversary meeting of the A.S.T.M. in June, 1952, particularly since the request indicated that individual members would not be approached.

It was also suggested that the secretary check with the American Zinc Institute and other associations to find out what their policy would be in this instance.

EDTA RESEARCH

The secretary explained that a new chemical compound, commonly known as EDTA shows great promise for the prevention and treatment of lead poisoning. He explained that considerable research was being conducted on this subject at a Georgetown University.

He read a letter from Dr. Benjamin Kissin, attached as Exhibit "C" requesting a grant of \$1500 to conclude some research already underway at the Jewish Hospital of Brooklyn, N.Y. on this subject. He said that he felt that there would be good public relations value in the Association being associated with the research on this product.

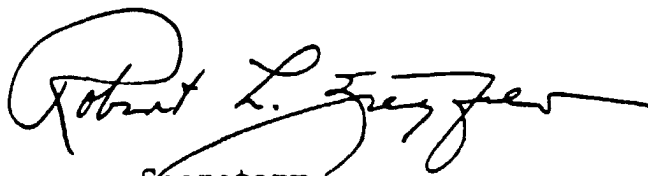
Members of the Board raised the question of whether, if the work was being conducted at a number of places, the grant would be most judiciously made to Jewish Hospital, and also whether if the grant were made to Jewish Hospital, the Association would not also be requested to contribute to the research at other places.

It was suggested that since Dr. Elston Belknap would address the Association later in the day, at least partly on this subject, the matter be tabled until the next meeting, at which time answers to the questions raised by the Board should be presented.

H.R. 7447 - LIFO

H.R. 7447 which would provide relief for companies which adopted LIFO during periods of high prices, was considered by the Board. It was the general feeling of the Board that this bill would be of benefit to some members and would not harm any. Therefore, the Board generally felt that the Association should actively support the measure. However, in order to be sure that no member opposes the bill, the secretary was requested to circulate copies of it to all members of the Association, telling them that the Board favored Association support of the measure and asking them if there were any opposition.

The American Society for Testing Materials came into being 50 years ago for the promotion of knowledge of the materials of engineering and the standardization of specifications and the methods of testing. Today it has nearly 8000 members, representing producers and consumers of engineering materials. You are no doubt familiar with the tremendous influence of the Society in its field. In the latter end of June the Society will hold a Golden Jubilee in New York City. It will be a large undertaking, requiring funds beyond the normal budget of the Society. Dear Mr. Bowditch:

I want to thank you again for the generous interest you showed in our work and for the pains and effort you spent to obtain an invitation for us to the meeting at the Massachusetts General Hospital. Dr. Sobel and I are very grateful.

In accordance with your suggestion, I will include here a brief description of our work and an estimate of what funds we will need to continue it. We have been using ethylene diamine tetraacetic acid in the prevention and treatment of lead poisoning. Thus far we seem to have been successful in preventing this condition but not in curing it. We feel that certain modifications in our medications, with which we have been experimenting, may overcome this obstacle.

Since our ideas are fairly well crystallized at this point, our experimental program is rather modest. We feel that we could probably accomplish that program in a six month period. Toward that, we would need about one thousand dollars for a technician and about five hundred for animals, or a total of \$1500.

Dr. Sobel will be unable to attend the meeting but I hope to see you there.
