REPORT OF THE TREASURER

The report of the treasurer was approved, as Exhibit "A" attached.

STATISTICS

Consumption Report - It was moved, seconded and carried that the Association make available its Lead Consumption Report for each year, at the year end, to the American Bureau of Metal Statistics for inclusion in the Bureau's Year Book.

Cooperation on Statistics - It was regularly moved, seconded and carried that the president and secretary investigate the possibility of avoiding duplication of effort between the various statistical organizations covering lead, such as the U. S. Bureau of Mines, the American Bureau of Metal Statistics and the Lead Industries Association.

Mine Production and Labor Report - The secretary presented copies of a sample condensed mine production and mine labor report which it was suggested should be circulated to all members of the Association. It was pointed out in the discussion that the U. S. Bureau of Mines already publishes monthly mine production reports and a question was raised as to whether the Association would be duplicating efforts of the Bureau. It was felt, however, that the Association's report, although not as complete as the Bureau's, would be useful because of its timeliness as compared with reports of the Bureau.

It was, therefore, regularly moved, seconded and carried that these condensed lead mine production and labor reports be circulated to all members as promptly as possible after the close of the month.

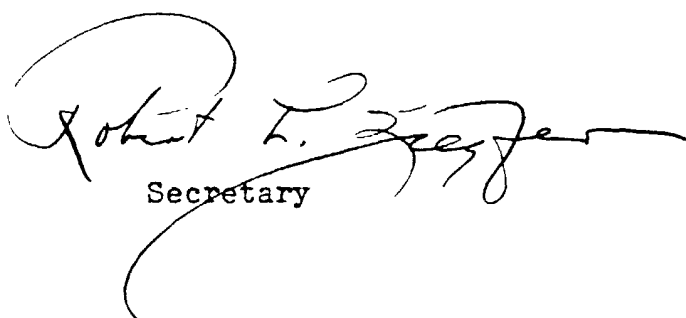
STATEMENT ON TOXICITY POLICY

The secretary submitted copies of correspondence with the American Zinc Institute regarding statements on the toxicity of lead and zinc products and was directed to record this correspondence in the minutes. This is attached as Exhibit "C"

REINVESTMENT OF FUNDS

The treasurer explained that \$47,000 of the Association's funds had been invested in 7/8% U.S. Certificates of Indebtedness expiring June 1, 1948. The treasurer requested the board to confirm the oral authorization to reinvest \$34,000 of this amount in 1-1/8% U.S. Treasury Certificates of Indebtedness expiring June 1, 1949, the other \$13,000 to be transferred to the Educational Service Division Fund as approved by the Executive Committee at its meeting on November 17, 1947. The Board made its approval of this transaction a matter of record.

There being no further business before the meeting, it adjourned at 2:25 P.M.

Dear Mr. Ziegfeld:

At a meeting of the Institute's Industry Development Committee on December 18th, one of the principal subjects of discussion was in connection with published statements which draw comparisons between the toxicity of lead and zinc products.

The important outcome was the endorsement of a statement of policy which declared that, while the American Zinc Institute and the Lead Industries Association should feel free to defend any unfair attack upon zinc and lead and their products, any defense measures used in behalf of one product which directly or indirectly, stated or implied, involve an attack upon another, should be declared inimical to the interests of the combined industries.

Furthermore, the question was raised as to the method to be employed in countering unfair statements made in the advertising of paint manufacturers and others. Again it was urged that in such cases the above statement of policy and all its limitations should govern but that there could be no objection if anyone, feeling injured and finding that direct appeals to offending manufacturers were unavailing, should seek the assistance of the National Paint, Varnish & Lacquer Association, directly or through its membership, to prevent or amend objectionable statements.

The Secretary undertook to convey the sense of the Committee's view to you and, in order that you may fully understand the basis for the discussion, I enclose a complete abstract of the Minute involved.

I shall be glad to have your comments and, if agreeable, your endorsement of the policy statement.

Abstract from minutes of meeting of the Industry Development Committee of the American Zinc Institute on December 18, 1947:

(4) TOXICITY. The Secretary drew attention to published statements that draw comparisons between the toxicity of lead and zinc products. Specifically, he mentioned the statement of Dr. L. L. Carrick in "Marine Primers" from the Official Digest of the Federation of Paint & Varnish Production Clubs of April 1947, which stated in part:

"Patients suffering from lead poisoning usually recover when removed from the environment of exposure. However, the careless use of the chromate pigments may subject the workmen to permanent injuries of which perforation of the nasal septum is a common type. (Ref. 13) This would indicate that the handling and application of zinc chromate paints should be rigidly controlled and subject to protective restrictions equal to those placed upon red lead paints."

This, the Secretary learned from the Secretary of Lead Industries Association, was to counter the statements made by Lt. Henry H. Nelson, U.S.N.R., in Circular 710 of the National Paint, Varnish & Lacquer Association, September 1945, in which Lt. Nelson mentions "the possibility of lead poisoning arising from the fumes while welding and cutting on surfaces painted with red lead paint" and gives this as a determining factor of great weight in the adoption of zinc chromate primer.

The Secretary deplored the use of invidious comparisons that could benefit no one and warned that their continuance would only lead to more of the same thing. He suggested that, inasmuch as many of the Committee's membership are interested in both lead and zinc, it might be helpful to establish a statement of policy which would be a guide and a strong influence upon all concerned and their trade organizations. Specifically, he stated that, while the Zinc Institute and the Lead Association should feel free to defend any unfair attack upon zinc and lead and their products, he believed that any defense measures used in behalf of one product which directly or indirectly, stated or implied, involve an attack upon another, should be declared inimical to the interests of the combined industries.

There was general agreement with this policy and no exception was taken. Therefore, the Secretary undertook to convey the sense of the Committee's view to the Secretary of the Lead Industries Association.

The question was raised as to the method to be employed in countering unfair statements made in the advertising of paint manufacturers and others. Again it was urged that in such cases the above statement of policy and all its limitations should govern but that there could be no objection if anyone, feeling injured and finding that direct appeals to offending manufacturers were unavailing, should seek the assistance of the National Paint, Varnish & Lacquer Association, directly or through its membership, to prevent or amend objectionable statements.

Dear Mr. Gent:

Referring to your letter of December 31 regarding a statement of policy on comparisons between the toxicity of lead and zinc products, the Lead Industries Association will be most happy to cooperate with the American Zinc Institute and will welcome any moves that will tend to eliminate such comparisons. Therefore, the Executive Committee of the Lead Industries Association at a meeting on April 2, 1948, subscribed in principle to the statement of policy outlined in your letter.

However, the Executive Committee feels that the assistance of the National Paint, Varnish and Lacquer Association in controlling comparisons, stated or implied, made by paint companies has not proven entirely satisfactory in the past. Therefore, it suggests that we refer such complaints to the American Zinc Institute and enlist its cooperation in correcting or preventing occurrences of such unfair statements.

We are all most anxious to prevent the appearance of statements which are inimical to either lead or zinc products and we sincerely hope that with your cooperation we may be able to prevent them in the future.
