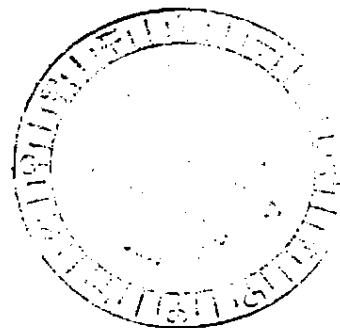
Health Examinetics has been acquired by MEDIQ, Incorporated, effective March 29, 1987.

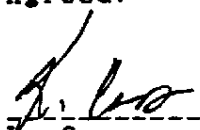
This will confirm our recent agreement to amend the URW/Uniroyal Health and Safety Memorandum of Agreement dated April 21, 1985. Specifically, Section 5(d) which specifies that copies of test results, health history profile and physical recommendations will be transmitted to the employees, the plant physician and the employee's designated physician. This letter will confirm that the parties have agreed to delete the reference in this paragraph to the plant physician and tests results, health history profiles and physical recommendations will now only be sent to the employee's designated physician and the employee.

This amendment in no way affects the existing health evaluation programs presently in place at Naugatuck Chemical, Naugatuck Synthetic, and Painesville which are covered under Section 5(e) of the Memorandum.

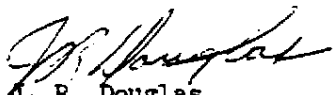
