Per your request, we have established ammonium perfluorooctanoate (FC-143) as one of the monthly parameters for which we normally sample outlets 002 and 005.

Samples were taken in October and November with the following results:

<u>Date Sample</u>	<u>Outlet</u>	<u>FC-143, micrograms per liter (ug/L)</u>
10/25/01	002	2.8
10/25/01	005	62.6
11/26/01	002	4.8
11/26/01	005	915

The FC-143 filtration system was in operation at the time the Outlet 005 sample was taken on October 25, 2001 but was not at the time the Outlet 005 sample was taken on November 26, 2001.

Please note that the laboratory and analytical method have changed since our last FC-143 data submittal.
