Dear Ms. Del Vecchio:

Following up our conversation of October 11, 1988, enclosed herewith, please find a complete copy of our file contents. We have separated them to indicate pleadings and general correspondence between counsel and correspondence we may have had with Sherwin-Williams' personnel. There is a short medical discovery file as well.

You will note, in reviewing these materials, that the co-defendant has yet to develop a case against Sherwin-Williams; and, we are dealing strictly with an asbestos case.

We are still attempting to locate much of the medical discovery that was not initially provided. At first, Sherwin-Williams was not a defendant, but simply a target; and, since they had not been formally joined, medical reports were not served on their office.

We hope to have everything organized within the next few weeks, and be in a better position to advise you as
