Attached is the very short three page document which we would like to discuss with you tomorrow. This is the proposal Moffat and Garfield County made prior to the Government Shutdown, and has never since been addressed.

If there is a couple minutes toward the end of our phone call, we would like to address the need for Interior to have BLM inventory roads within Lands with Wilderness Character (LWC's). BLM has not acknowledged the existence of roads within LWC's and a 12 year statute of limitations is fast approaching, with no intent to address the problem.
