On examination, he has a false upper denture and a partial lower denture. There are no abnormal findings in his gums. There is no abdominal tenderness. The bowel sounds are normal. On neurological examination, the deep reflexes are normal. The Romberg test is normal. There is no evidence of a wrist drop or of any weakness. There was no impairment of the sensations.

The blood pressure was 120/80. The pulse rate was 60.

From this two month consultation, I find no medical condition that would place the employee at increased risk or impairment of health from continued exposure to lead.
