

BIODEGRADATION (BOD/COD)

TEST SUBSTANCE

Identity: Perfluorooctanoic acid, ammonium salt; may also be referred to as PFOA ammonium salt, Ammonium perfluorooctanoate, FC-116, FC-126, FC-169, or FC-143. (Octanoic acid, pentadecafluoro-, ammonium salt, CAS # 3825-26-1)

Remarks: The 3M production lot number was not noted. The test sample is FC-126 and is referred to by the testing laboratory as E1282-1 and E1282-2. It's purity was not sufficiently characterized, though current information indicates it is a mixture of 78 - 93% test substance and 7 - 22% C₅, C₆, and C₇ perfluoro analogue compounds.

METHOD:

Method: EPA approved standard method numbers 507 and 508A.

Type: Aerobic (BOD) and Dichromate reflux (COD)

RESULTS

CONCLUSIONS

No reliable conclusions can be derived from this study.

DATA QUALITY

Reliability: Klimisch ranking 4. Summary was created using only a listing of test values. The original study procedure and raw data were not found. However, there was a discrepancy noted in the data values. Data

was reported as "mg/L" by the testing laboratory, but was entered as "mg/kg" values in the 3M Environmental Laboratory archive system without proper conversion from volume to mass units. Therefore, the data is invalid as stated.
