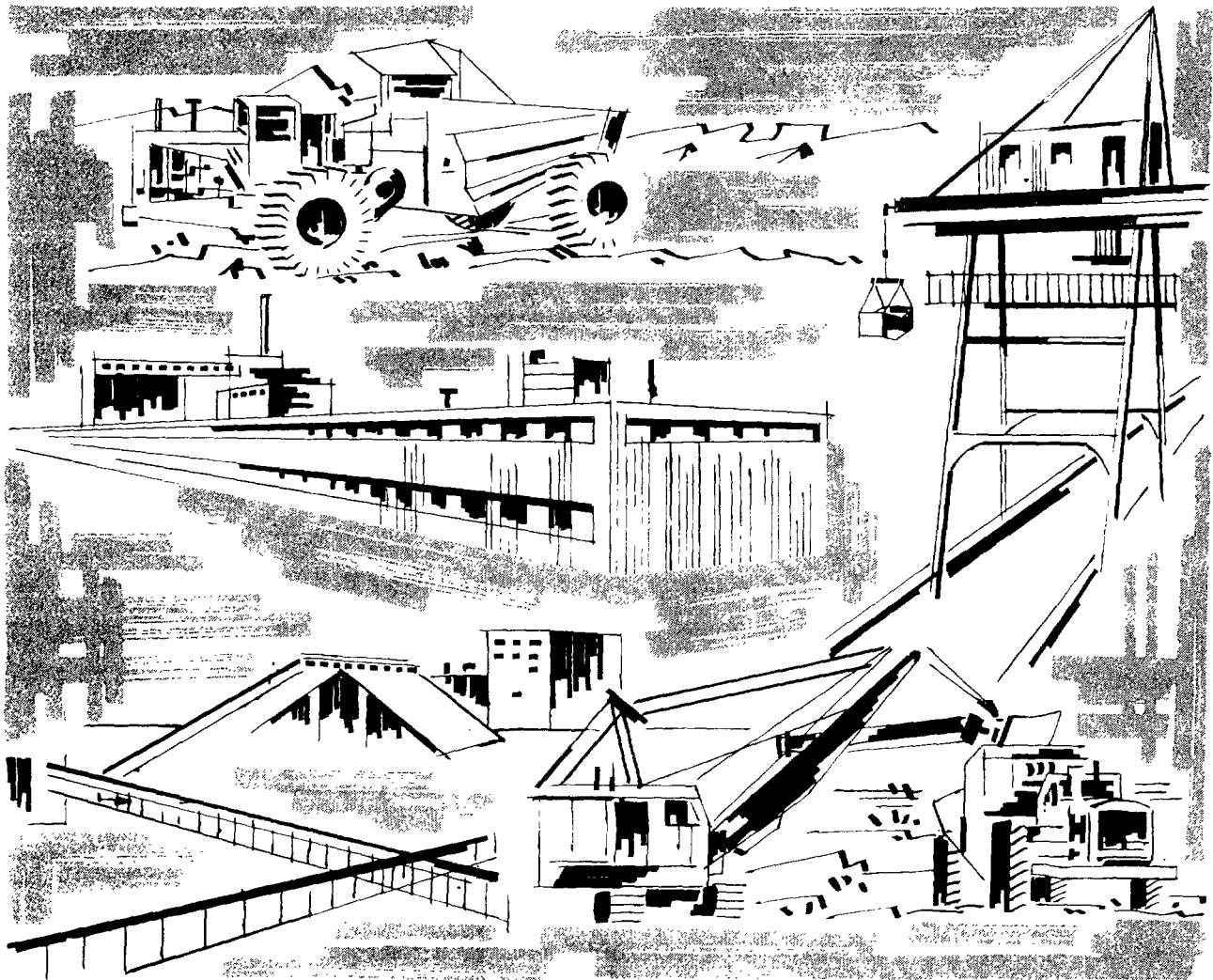
Information thusly presented provides you a ready check to areas of plant operations that require attention and should provide the stimulus for the planning of remedial action.

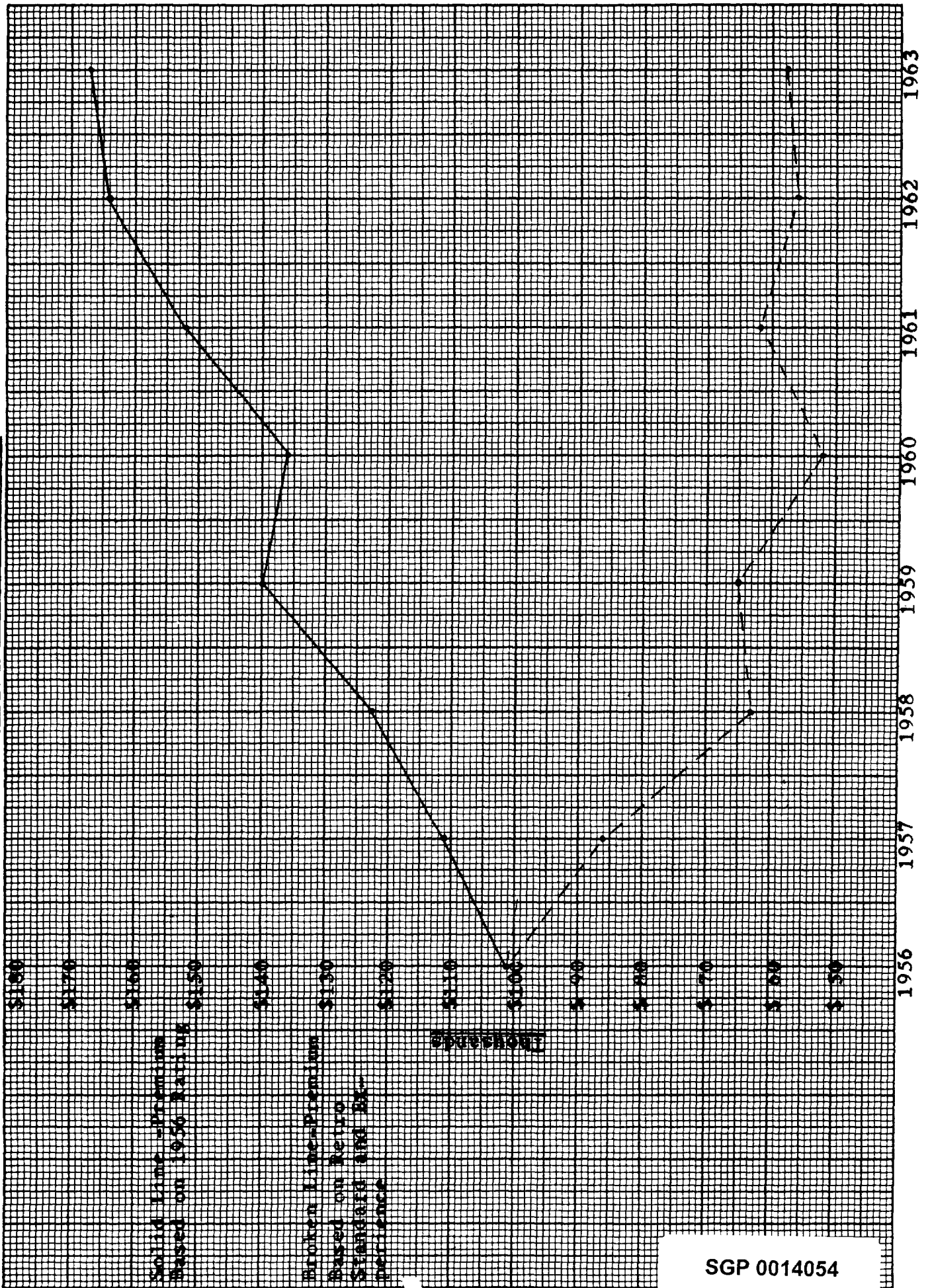

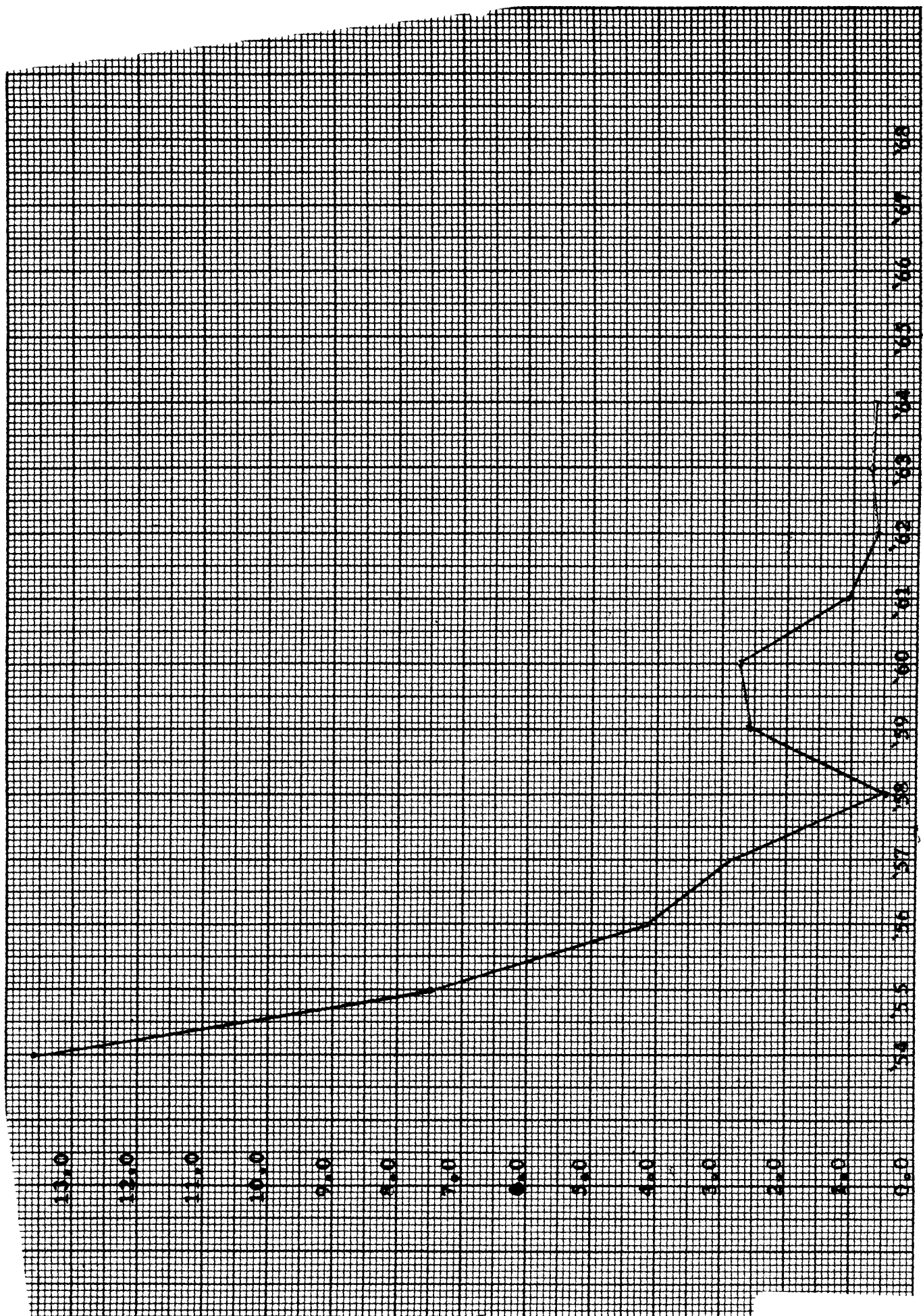

RATINGS PER \$100 PAYROLL

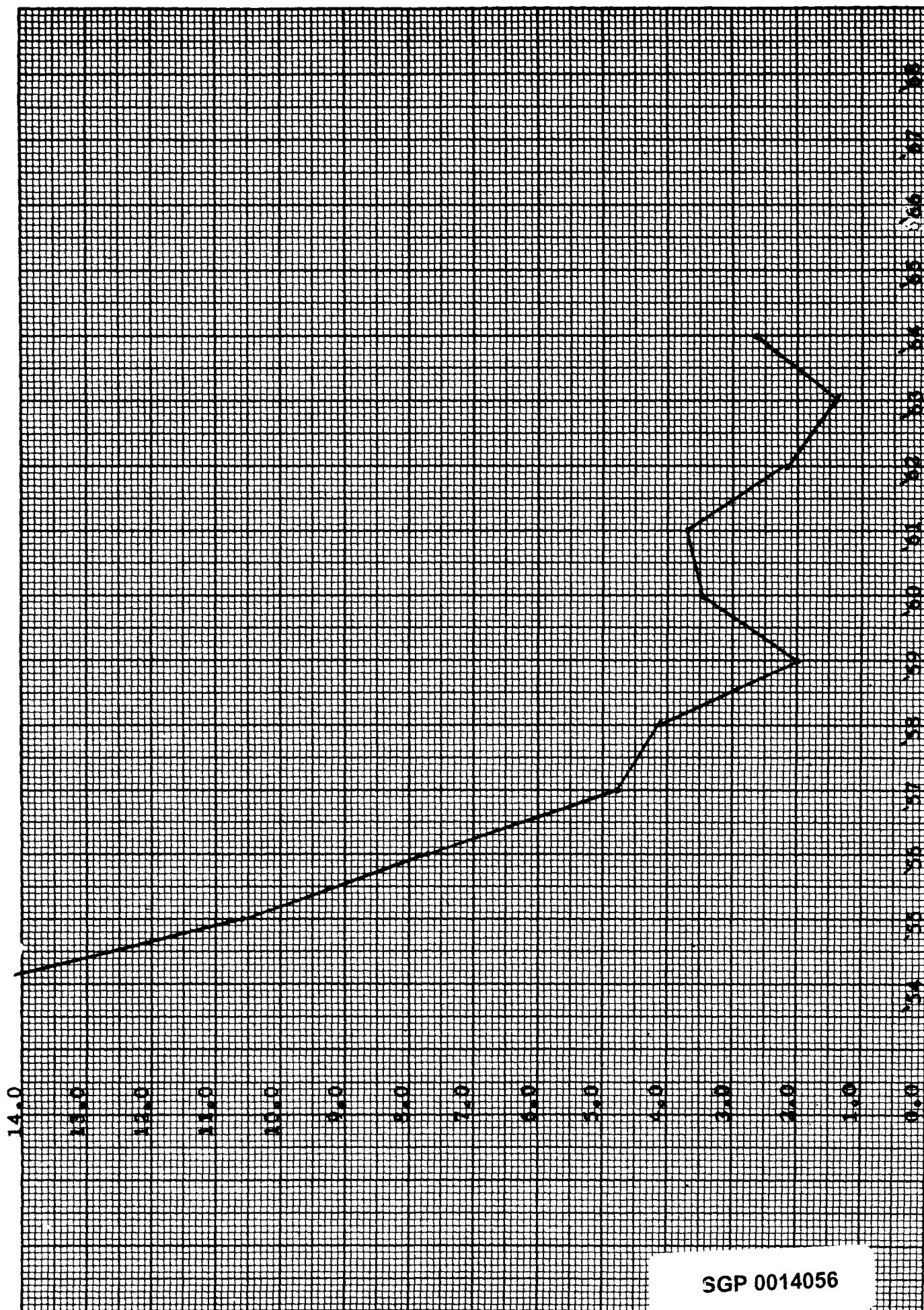


LAND FREQUENCIES - GYPSUM PLANTS
