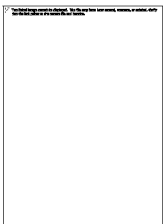

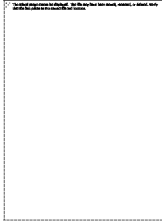
- What time do you want to start and end?
