I have suggested that Ed call and check with you to see exactly what you think Dr. Vorwald has in mind. We will be glad to cooperate in any way.

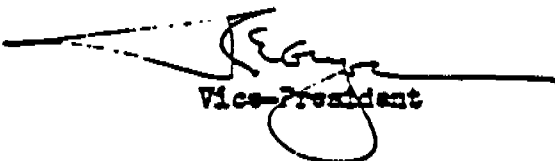
