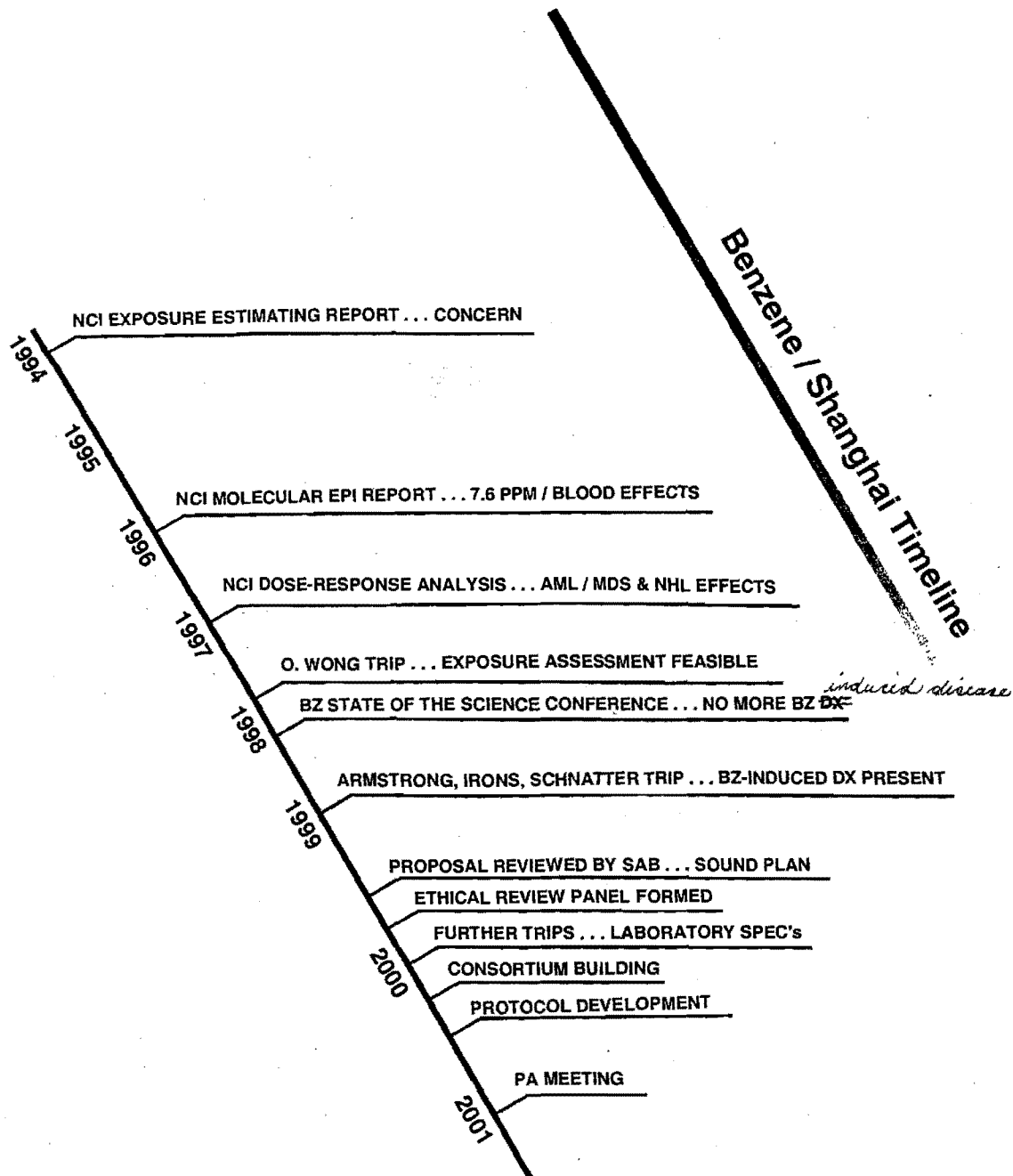

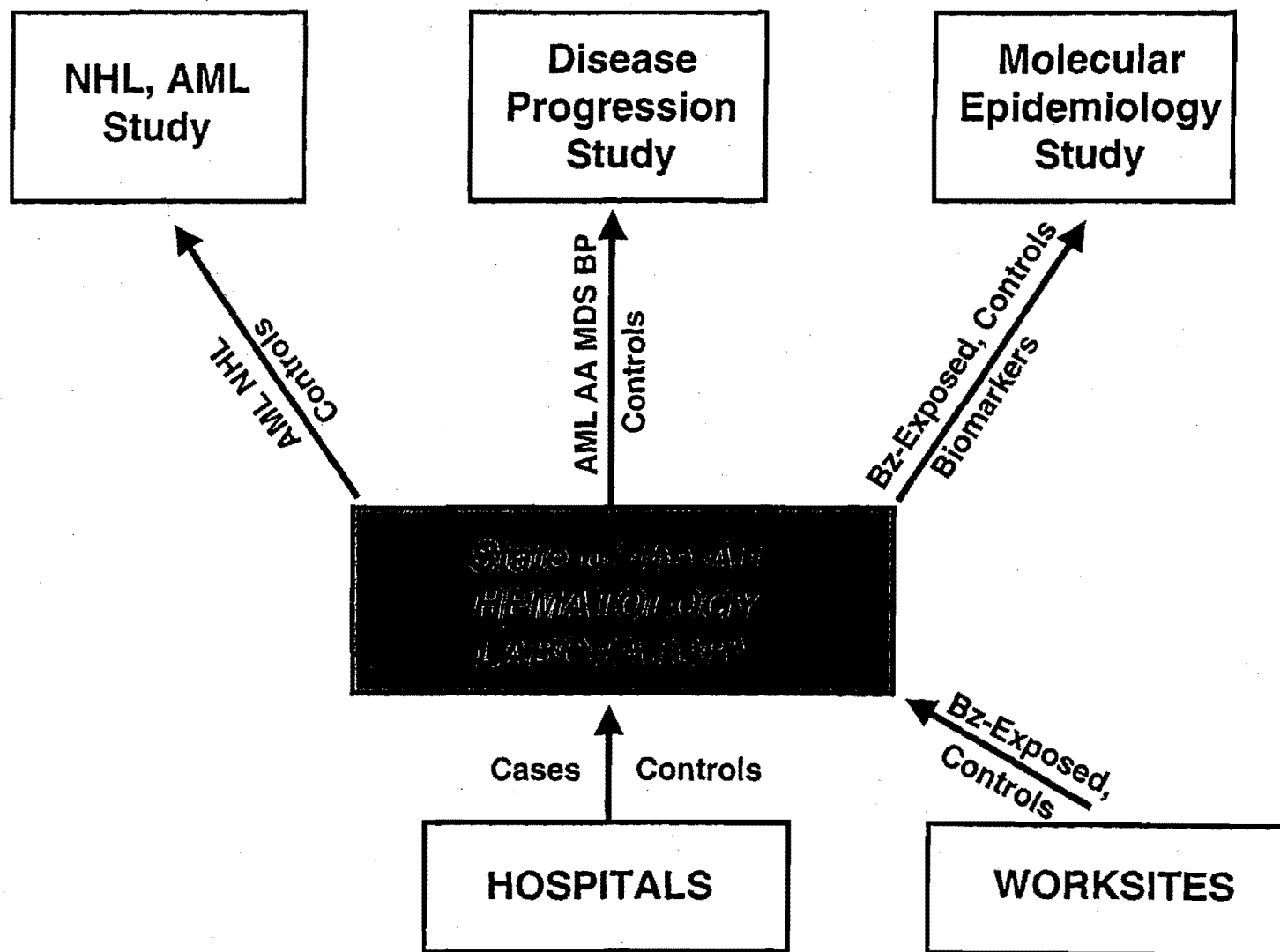

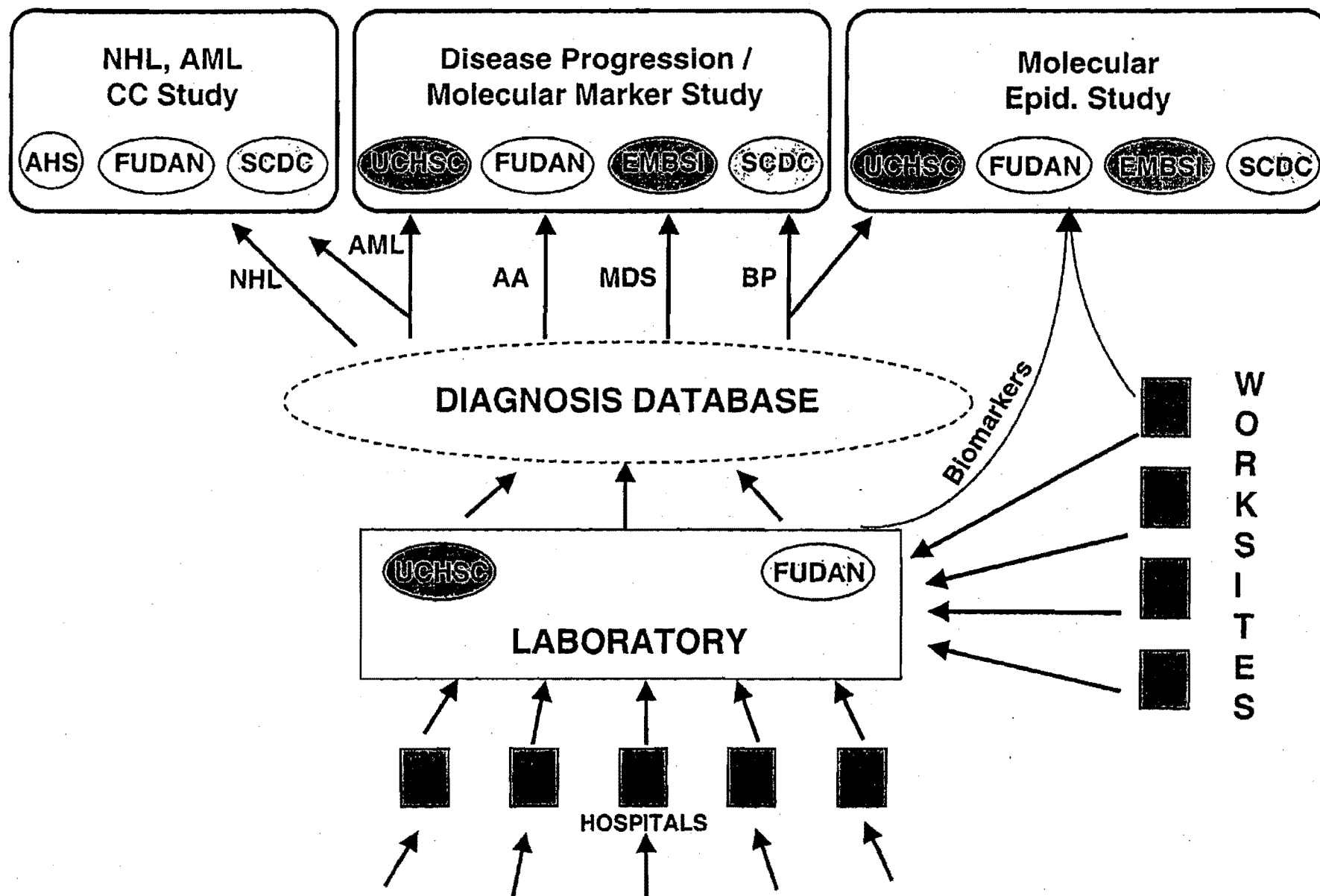




Shanghai Benzene Study Structure

Why Shanghai?

- Largest Contributor to NCI Study
- Large Population (~14 million)
- Organized to Support Research (Fudan, SCDC, etc.)
- Exposures Relatively High, But Decreasing
- Willing Collaborators
 - Research know-how
 - Regulatory interest, mandate
 - Technology imports
- Influential Contacts

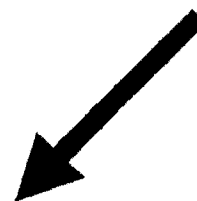
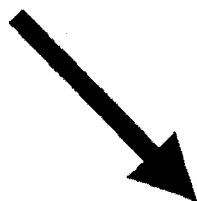
