## MICHIGAN

H.110 (#17)\* Smoke Regulation. Reported with Amendment February 6. Second reading February 7. Third reading February 7. Passed House February 8. Referred to Senate Judiciary February 11.

## KENTUCKY

H.173 Water Pollution. Amends Section 220.600, R.S., relating to the water pollution control commission. Introduced January 21, 1952. Referred to Statutes No. 2, January 23. Reported favorably January 24. Second reading January 29. Third reading January 29. Passed House January 29. Referred to Senate Statutes No. 2, January 31. Reported favorably January 31. To third reading February 1. Passed Senate February 4. Approved February 7.

S.147 Air Pollution. To control and suppress air pollutions creates county air pollution control districts. Introduced February 6, 1952. Referred to Municipalities in Senate, February 13; reported favorably, February 14. To second reading February 15; to third reading February 15. Passed Senate, February 19.

## MARYLAND

S.41 Air Pollution. To amend Sec. 116 of Art. 43 of the An. Code increasing the appropriation for study and control of smoke or air pollution. Introduced February 11. To Rules. Referred to Finance February 14.

## MASSACHUSETTS

H.2014 Pollution. (Reported in #17 as H.1324) To authorize additional municipal indebtedness for certain health purposes. Introduced January 24, 1952. Hearing in House; reported by Substitute January 24. To third reading February 5.

## MICHIGAN

H.170 Water Pollution. Amends CL 1948, section 307.30 to Federal section as to fouling waters for fishing inapplicable to fills or other operations necessary to control damage caused by waters of the Great Lakes. Introduced January 24, 1952. To Conservation January 24. Reported amended in House February 12. To second

reading in House, February 13. To third reading, February 13. Recommitted to Constitution in House, February 21.

H.171 Water Control. To effectuate necessary coordination among Federal, state and local governments relative to control and damage caused by or to waters of the state. Introduced January 24, 1952. To Conservation January 24. Reported favorably in House February 14. Amended in House February 21. Passed February 21.

## MISSISSIPPI

H.199 Stream Pollution. Requires payment of a sum not exceeding \$100 per year from every person, firm, association or corporation discharging industrial waste into the streams of the state. Introduced February 7, 1952. To Game Fish & Wildlife, February 7.

H.359 Stream Pollution. Amends Section 1172, Code of 1930, and Section 2415, Code of 1942, Annotated, to prevent pollution of streams. Introduced February 19. To Judiciary.

## NEW JERSEY

A.200 Workmen's Compensation. To amend the workmen's compensation law, proposes among other things that an injured employee may, when care is required, select to treat him any duly licensed physician and proposes that if the employee is unable to do so, or elects not to do so, the employer shall promptly provide him with the necessary medical care.

## NEW YORK

AR.73 Air Pollution. Memorializing the House of Representatives to pass Resolution 215 providing for a survey and study of air pollution in industrial areas throughout the U.S. Introduced February 5. To Rules February 5.

SR.54 Air Pollution. Same as AR.73. To Finance February 5.

A.615 Water Pollution. Gives state water pollution control board power to make necessary rules and regulations and perform acts not inconsistent; prescribes restrictions under which permits for new outlets or new or extended disposal systems may be issued, to protect public health, public enjoyment of receiving waters. Introduced January 21, 1952. Referred to Senate Health February 13.

A.849 Pollution. Creates temporary commission of 12 members to study and prevent pollution of waters of Atlantic Ocean and Long Island Sound adjacent to Long Island, the Rockaways, Coney Island and Brighton Beach; appropriates \$50,000. Introduced January 22, 1952. To Ways and Means, January 22.

S.627 Pollution. Same as A.849.

S.1390 } First-Aid Stations. To amend the labor law, proposes that in every industry, trade or occupation where 50 or more persons are employed, the labor board shall require the establishment of a first-aid station under the guidance of a competent person whose sole duty shall be providing aid for injuries received during employment.

A.868 }  
S.784 } Workmen's Compensation. To amend the workmen's compensation act, proposes to authorize the board upon application made by an employee, employer, or carrier, to cause an examination of an injured employee by a physician designated by the commission especially qualified with respect to the diagnosis or treatment of the disability for which compensation is claimed.

H.1481 Pollution. To prohibit the releasing of oil, sludge, acid, cinders, ashes, from a vessel into the waters of the Hudson or Mohawk Rivers. Introduced February 5. To Conservation. Reported favorably February 20.

S.1257 Pollution. Same as H.1481. Introduced February 5.

S.1713 Water Pollution. Gives state water pollution control board power to make necessary rules and regulations and perform acts not inconsistent. Introduced February 12. To Health February 13.

S.1493 } Workmen's Compensation. To amend the workmen's compensation law, propose to require physicians and medical consultants to furnish to claimants, or their authorized representatives, copies of every report of examination, finding and opinion made by such physician and medical consultant with respect to the claimant.

VIRGINIA

H.511 Pollution. To prohibit the discharge of oil generally, in certain waters. Introduced February 11, 1952. To General Laws, February 11.

H.771 Pollution. To provide that the State Water Control Board may maintain an action to recover the value of fish killed by pollution, and to appropriate any funds thus recovered for the replacement of fish by the Commission of Game and Inland Fisheries. Introduced February 18. To General Laws.

H.812 Pollution. To provide that sewage from facilities serving five hundred persons shall be deemed to be pollution; that unsatisfactory progress toward compliance with any special order of the Board shall entitle the Board to take certain other action; that the Board may recover the value of fish killed by pollution. Introduced February 18. To General Laws.

- H.813 Water Pollution. To repeal Sec. 62-11 of the Code requiring a fee for the issuance of a certificate to discharge waste into State waters. Introduced February 18. To General Laws.
- H.814 Pollution of Waters. To amend Sec. 62-41 of the Code, relating to pollution of State waters. Introduced February 18. To General Laws.
- H.815 Water Control. To provide that any provision in any charter in conflict with the State Water Control Law is repealed. Introduced February 18. To General Laws.
