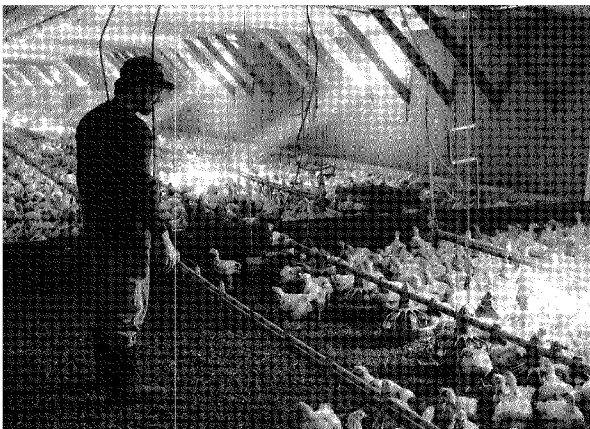
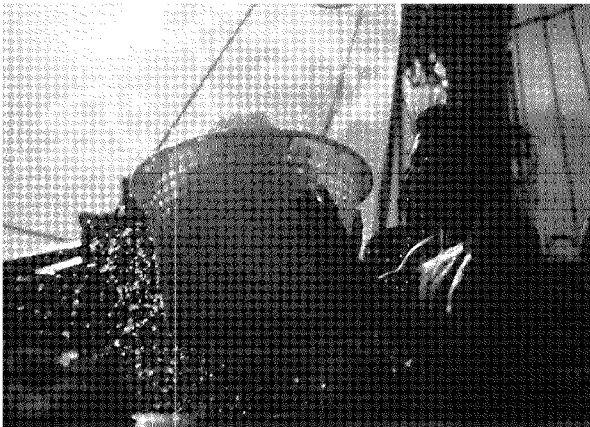
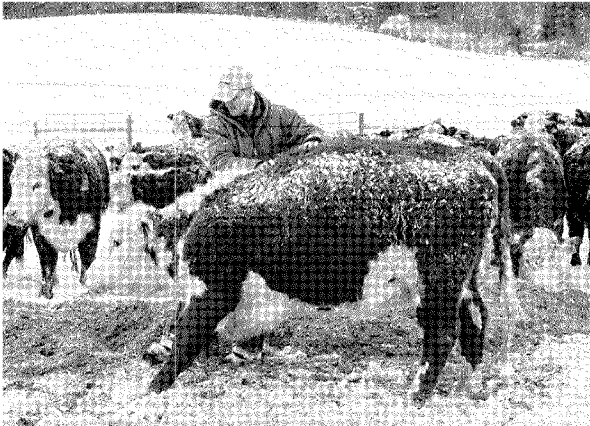
### PROGRAMMING

### EVENTS

The Concordia Annual Summit takes place in New York City in September around the United Nations General Assembly and serves as a global affairs forum for thought leaders and innovators to examine the world's most pressing challenges. Concordia's Regional Summits, which thus far focus on Latin America and Europe, address the pressing political and economic priorities of specific regions and act as idea incubators leading up to the Concordia Annual Summit.

To complement these signature Summits, Concordia regularly hosts smaller events that feature experts and industry leaders from our Leadership Council, Membership Program, and the Concordia community.

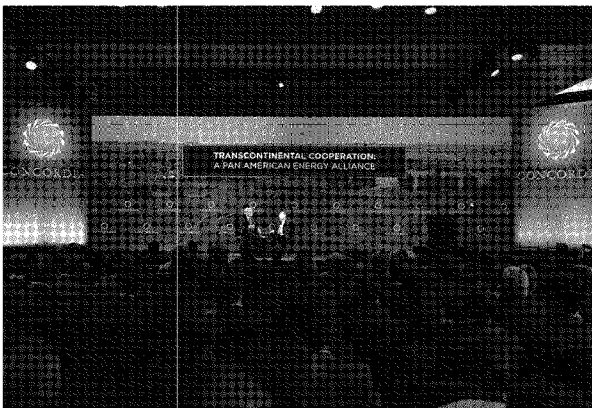

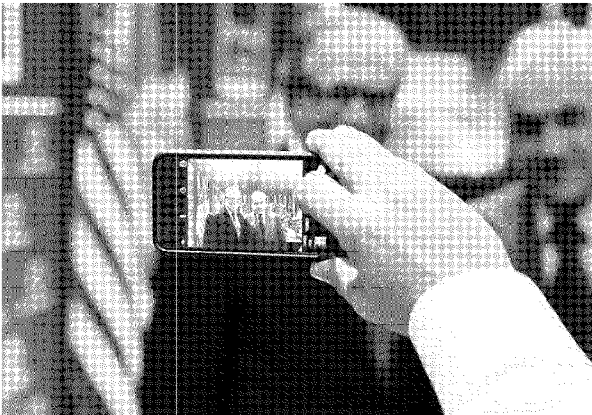

Strategic Dialogues will feature 30-50 select individuals, including current and former heads of state, Chairs and CEOs of leading corporations, and multi-lateral organizations, who will discuss particularly pressing global problems. These curated, interactive discussions will serve as high-level working groups that will produce deliverables such as policy recommendations, collections of challenge opportunities, or repositories of best practices.

### ROUNDTABLE DISCUSSIONS

Concordia's Roundtables allow for extended discussion among a small group (15-20 per session) of experts on a specific topic in industry, public policy, or of regional concern. Typically led by former or sitting heads of state, industry pioneers, and civil society leaders, roundtables provide a more analytical framework for assessing large-scale global problems. Expanding beyond plenary stage presentations, roundtables offer Member the rare opportunity to listen to in-depth analysis and expert viewpoints on the salient solutions made possible by public-private partnerships.
